### Capability and Description

The Regulatory Compliance Platform Version 1.4 is a cloud-based modular application that when used in combination with other Health IT Modules forms a complete CEHRT solution for healthcare professionals in ophthalmology and optometry in outpatient ambulatory environments. It allows users to perform a wide range of functions such as:

- Monitor MIPS Performance and provide Promoting Interoperability calculations for the Medicaid EHR Incentive Program for ECs.
- Report information to PHAs (public health agencies) and clinical data registries and allow integration with APM entities.
- Create "gold standard" electronic health information documents required for referrals, transitions of care and to share with the patient
- Send/receive messages and attached documents to/from the HISP via Direct Edge Protocol.
- Bulk export of CCD files
